Each time a participant books a DATS pick-up or drop-off trip to ACT for these programs, the DATS vans or buses reserve a time slot in their system to ensure that the participant can be picked up to attend these programs. *The Adult Senior Leisure Dance will continue as a drop-in program for individuals who do not require the use of DATS services to this program.*

All participants using DATS must complete and return this registration form prior to attending the upcoming session.

Avoid Delays! Please send form early to allow time for processing.

Anyone requiring the use of DATS for transportation to the Seniors Dance must register for this program. A registration *form must be filled out* and sent to ACT Aquatic & Recreation Centre.

This will continue to give participants the independence to choose the dates they want to attend the program and to continue to develop money management skills.
