A subgroup will be formed with representatives from ART, IRRT, TF, and hopefully one from the province to formulate a broader definition which would include aboriginal perspectives. • Brenda will extract excerpts for poverty definition exercise from the ART Assignment Interview document. • Rachelle will be the ART representative for the poverty definition exercise. • Cheryl will be the ART representative for June 17 Task Force meeting. • ART may decide to meet again to review before June 17, should it be necessary to go over the inputs for the definition.

"We need to figure out what we want to do together." <p>Lisa will start the email discussion on events:</p> <ul style="list-style-type: none"> • Large organized events for engagement are possible e.g. Inner City Barbeque with the advantage being that people living in poverty will be there. <p>It was also proposed to have focus groups with guest speakers and/or a questionnaire:</p> <ul style="list-style-type: none"> • Simple questions should be formulated. • It is important to hear the stories of the Aboriginal people. • Staff members who are familiar with Aboriginal poverty should be involved.
