### 1. Request to name roads located within the Blatchford Neighbourhood.

That the Naming Committee does not support the naming of the former runways using their original numbered names of 12/30 and 16/34 as 'Twelve-Thirty Road' and 'Sixteen-ThirtyFour Road' due to the concerns expressed by Emergency Response, Fire Rescue, Transportation traffic operations, Addressing, Canada Post, Telus 9/11, and Edmonton Police.
