River Valley Connections The City of Edmonton has partnered with River Valley Alliance on five initiatives that will contribute to creating one of the largest connected metropolitan river valley parks in the world. Two of these projects, Mechanized River Valley Access and Boat Docks and Launches, are in the planning stage and we want to hear from you!

Both initiatives are fully funded by the River Valley Alliance, the provincial and federal governments, and the City of Edmonton, and are scheduled for completion by the end of 2016.

Mechanized River Valley Access: A primary goal of this project is to support connectivity and accessibility to the river valley for all citizens—regardless of age or ability.

Boat Docks and Launches: In recent years, there has been interest in expanding river valley recreation to include activities on the North Saskatchewan River. As part of this effort, the City of Edmonton is preparing to build docks and launches to get people closer to and onto the water.

MECHANIZED RIVER VALLEY ACCESS

About the project

The Mechanized River Valley Access project aims to connect Edmonton's downtown to the existing river valley trail system. The project will include innovative urban design that will facilitate access to the river valley and will allow people to travel from our vibrant downtown to connect with nature within minutes.

1) The City has been studying the feasibility for a mechanized access project that will connect the downtown to the river valley. Two alignments have been explored. The City's consultants are recommending the east alignment. What are your thoughts?

BOAT DOCKS AND LAUNCHES

About the project

This initiative aims to increase access to the North Saskatchewan River. The docks and launches will provide more opportunities for recreational boating, allow travel along the river and create places for the public to get closer to the river.

Seven docks and three boat launches are being considered in the following locations:

- Whitemud Park (dock and hand launch)
- Laurier/Buena Vista Park (dock)
- William Hawrelak Park (dock)
- Emily Murphy Park (dock and hand launch)
- Rossdale (dock)
- Dawson Park (dock)
- Capilano Park/50th Street (dock and refurbishment of existing vehicle launch)
