Edmonton Census 2014 - Worker Application Form

The City of Edmonton requires Census Workers 18 years of age or older to represent the City during the 2014 Census. Workers will go door-to-door in assigned areas to collect census information. Requirements include: good interpersonal skills, the ability to deal with sensitive issues, a high attention to detail and the capacity to work flexible hours including days, evenings and weekends. This year, for the first time, residents have the option of completing the census online from April 10 – 27, 2014. Therefore, workers may be assigned to a geographically larger area and must have use of a vehicle with proof of valid insurance. **Door-to-door collection will begin May 10.**
