RE: Tentative plan of subdivision to create one institutional lot and one medium density residential lot from portions of Plan 9323281, Block 19, Lot 1C located north of 129 Avenue NW and east of 68 Street NW, **BALWIN**

I The Subdivision by Plan is APPROVED on July 24, 2008, subject to the following conditions:

1. that the owner enter into a Servicing Agreement with the City of Edmonton pursuant to Section 655 of the Municipal Government Act;
2. that the owner prepare necessary plans and documentation to grant new or carry forward existing easements and restrictive covenants in favour of the City of Edmonton, EPCOR Distribution Inc., EPCOR Water Services Inc., and ATCO Gas, as required by the aforementioned agencies or shown on the engineering drawings that are deemed to be part of the servicing agreement;
3. that the owner register an emergency access easement in the location as shown on the "Conditions of Approval" map, Enclosure I, to the satisfaction of the Transportation Department; and
4. that the owner pay all outstanding property taxes prior to the endorsement of the plan of subdivision.

II That the Servicing Agreement required in Clause I (1) contain, among other things, the following:

1. that the owner pay all costs identified in the Servicing Agreement, among other things, assessments and roadway modification costs, construction costs and inspection costs occasioned by this subdivision prior to the endorsement of the plan of subdivision;
2. that the owner submit detailed Engineering Drawings and technical studies in accordance with the City of Edmonton Design and Construction Standards and to the satisfaction of the City Departments, including the Heritage Unit, and affected Utility Agencies;
3. that the Engineering Drawings include the construction of a water main extension as shown on the "Conditions of Approval" map, Enclosure I to the satisfaction of Epcor Water;

4. that the owner construct a 1.8 m chain link fence as shown on the "Conditions of Approval" map, Enclosure I; and
5. that the owner is responsible for the design, landscaping and construction within the public utility lots, utility rights-of-way, road islands, boulevards, medians, walkways, and Municipal Reserve parcels, to the satisfaction of the Community Services, Transportation and Asset Management and Public Works Departments.

Enclosure I is a map of the subdivision identifying major conditions of this approval.

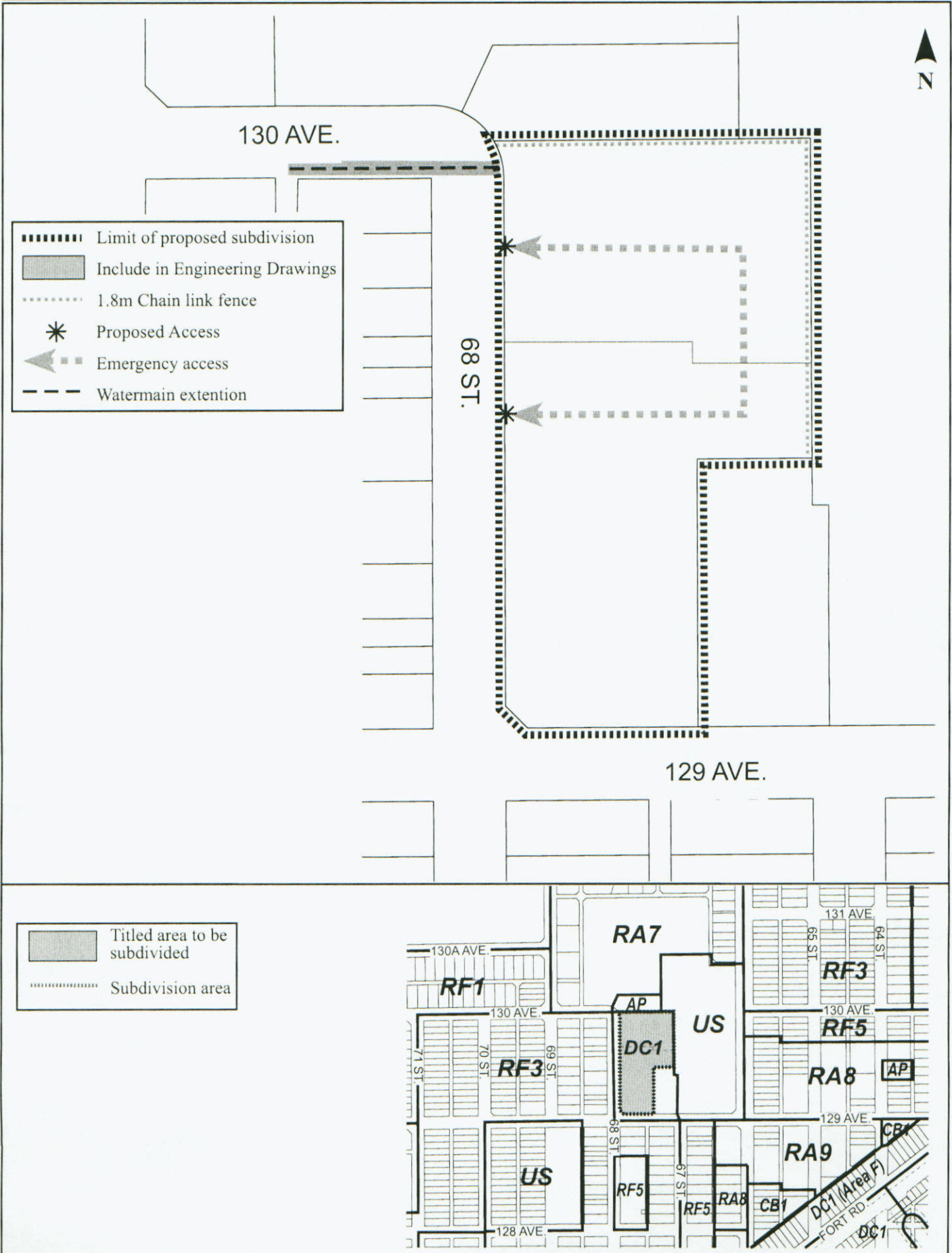

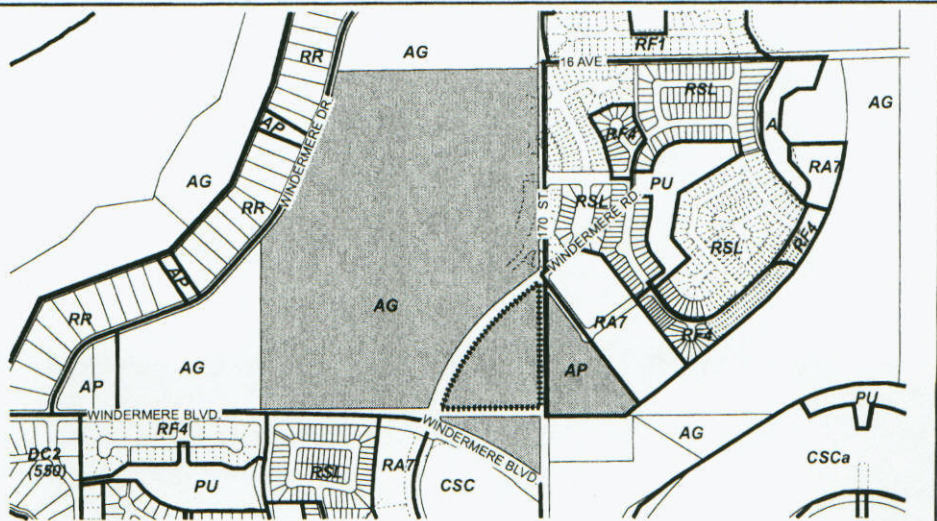

I The Subdivision by Plan is APPROVED on July 24, 2008, subject to the following conditions:

1. that the owner dedicate Municipal Reserve as a 0.016 ha parcel, plus 1.622 ha owing by a Deferred Reserve Caveat registered against the remainder of Lot B, Block 1, Plan 1009TR, as shown on the "Conditions of Approval" map, Enclosure I;
2. that the owner provide Municipal Reserve in the amount of 0.8095 ha by a Deferred Reserve Caveat registered against Lot 2, Block 1, Plan 1009TR pursuant to Section 669 of the Municipal Government Act;
3. that the owner provide Municipal Reserve in the amount of 3.279 ha by a Deferred Reserve Caveat registered against SE-14-51-25-4 pursuant to Section 669 of the Municipal Government Act;
4. that the owner enter into a Servicing Agreement with the City of Edmonton, pursuant to Section 655 of the Municipal Government Act;
5. that the owner be permitted to register this plan of subdivision in stages, as shown on the "Conditions of Approval" map. Enclosure I, at the discretion of the Senior Subdivision Officer, having regard to the provision of roadways and the logical extension of services;
6. that the approved subdivision within the Chappelle Neighbourhood (File No. LDA07-0489) be registered prior to or concurrent with this application;
7. that Bylaw 14989 to amend the Zoning Bylaw from AG to RSL, AG to PU and AG to AP (LDA07-0524) be approved prior to the endorsement of Stage 1 of the plan of subdivision;
8. that LDA08-0202 to amend the Zoning Bylaw from AG to RSL and AP be approved prior to the endorsement of Stage 2 of the plan of subdivision;
9. that the property line and road right of way dedication conform to an approved Concept Plan or to the satisfaction of the Transportation Department for 141 Street SW;

10. that the owner prepare the necessary plans and documentation to grant new or carry forward existing easements and restrictive covenants in favour of the City of Edmonton, EPCOR Distribution Inc., EPCOR Water Services Inc., and ATCO Gas, as required by the aforementioned agencies or shown on the Engineering Drawings that are deemed to be part of the Servicing Agreement; and
11. that the owner pay all outstanding property taxes prior to the endorsement of the plan of subdivision.

II That the Servicing Agreement required in Clause I (4) contain, among other things, the following:

1. that the owner pay all costs identified in Servicing Agreement, among other things, assessments and inspection costs occasioned by this subdivision prior to the endorsement of the plan of subdivision;
2. that the owner pay the proportionate share of the Permanent Area Contributions and/or lateral Sewer Oversizing Charges for the construction of permanent storm and sanitary drainage facilities in the basin;
3. that the owner submits an Erosion and Sediment Control (ESC) Plan specific for this development and for implementation during and after construction in accordance with the City of Edmonton ESC Guidelines and Field Manual;
4. that the owner pay the proportionate share of the Arterial Roadway Assessment for the construction of arterial roadways in the catchment area;
5. that the owner submit detailed Engineering Drawings and technical studies in accordance with the City of Edmonton Design and Construction Standards and to the satisfaction of the City Departments and affected utility agencies;
6. that the servicing boundary be amended to include the stormwater management facility (swmf) with Stage 1, as shown on the "Conditions of Approval" map, Enclosure I;
7. that no Construction Completion Certificate's (CCC's) for storm and sanitary sewers shall be issued until the offsite sanitary and storm systems are operational;
8. that the owner construct water main stubs at points A and B and water main construction from point B to C, as shown on the "Conditions of Approval" map, Enclosure I;
9. that the owner construct the east-west collector roadway as a minimum 14.5 m carriageway, to the first northerly local road intersection as shown on the "Conditions of Approval" map, Enclosure I;
10. that the owner construct 141 Street SW, with a 3.0 m multi-use trail from 25 Avenue SW to the east-west collector roadway as shown on the "Conditions of Approval" map, Enclosure I;
11. that the owner provide a temporary roadway connection with Stage 1, as shown on the "Conditions of Approval" map, Enclosure I. The temporary roadway connection will be required at FAC for paved roads or earlier, at the discretion and direction of the Transportation Department. The temporary roadway connection will be removed with the development of Stage 2 as a permanent emergency access will be provided with Stage 2;

12. that the owner withhold development of lots, as shown on the "Conditions of Approval" map, Enclosure I, until such time as the temporary emergency access is no longer required or as deemed appropriate by the City of Edmonton;
13. that the owner construct an offset 17 m radius asphalt temporary transit turnaround with bollards, as shown on the "Conditions of Approval" map, Enclosure I. The turnaround will be required at FAC for paved roads or earlier, at the discretion and direction of the Transportation Department;
14. that the owner construct a 3.0 m asphalt multi-use trail with a dividing yellow centerline and "shared use" signage, as shown on the "Conditions of Approval" map, Enclosure I;
15. that the owner construct a 1.5 m concrete sidewalk with bollards and lighting, as shown on the "Conditions of Approval" map, Enclosure I;
16. that the owner construct an emergency access walkway with a 3.0 m concrete sidewalk, T-bollards and lighting, as shown on the "Conditions of Approval" map, Enclosure I;
17. that the owner construct all fences positioned wholly on privately owned lands as shown on the "Conditions of Approval" map, Enclosure I; and
18. that the owner is responsible for the design, landscaping and construction within the public utility lots, utility rights-of-way, road islands, boulevards, medians, walkways, and Municipal Reserve parcels, to the satisfaction of the Transportation and Asset Management and Public Works Departments.

Please note, reserves owing against NE-14-51-25-4 have been addressed with LDA07-0489. The existing DRC shall be carried forward on title.

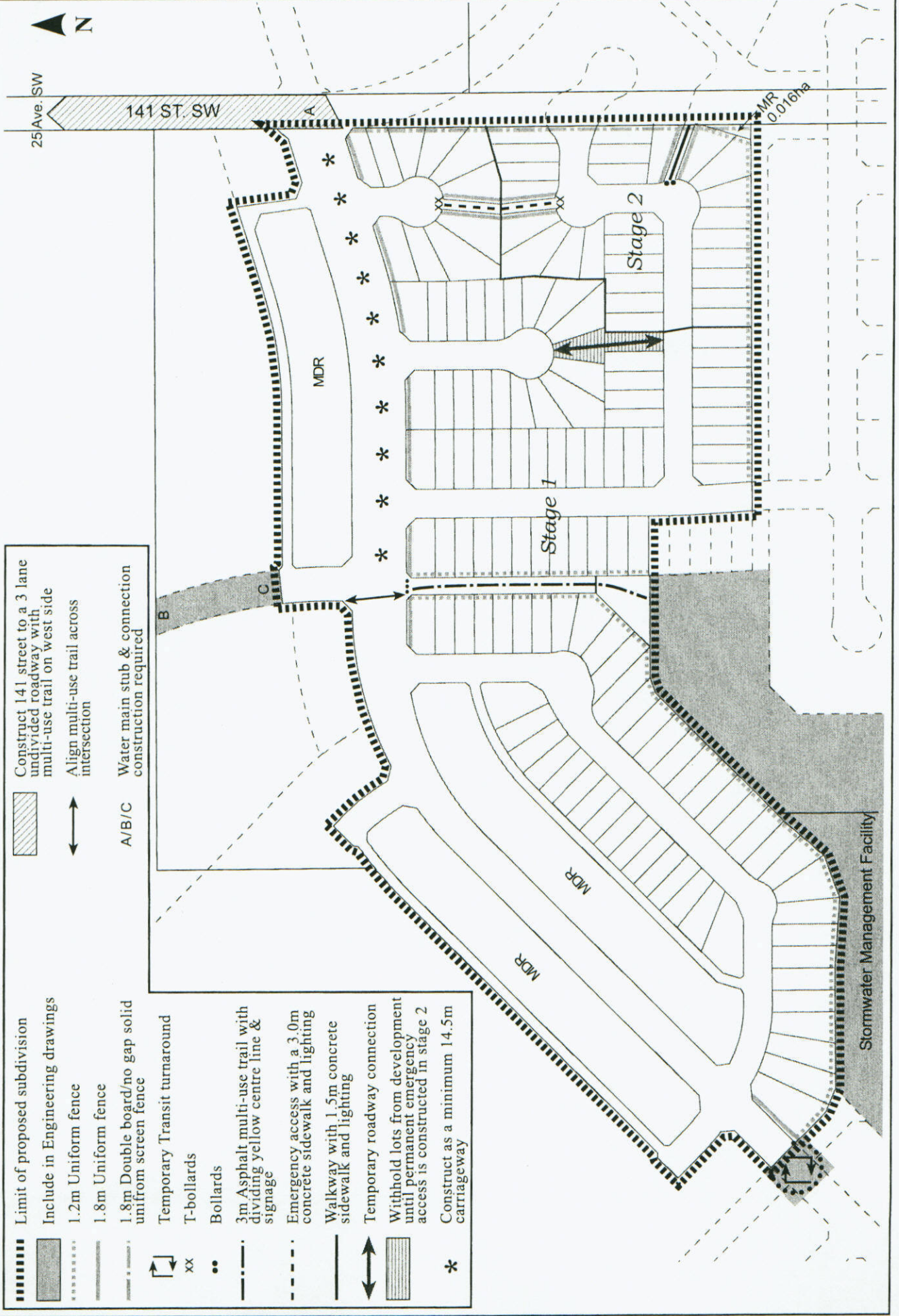



Titled area to be subdivided



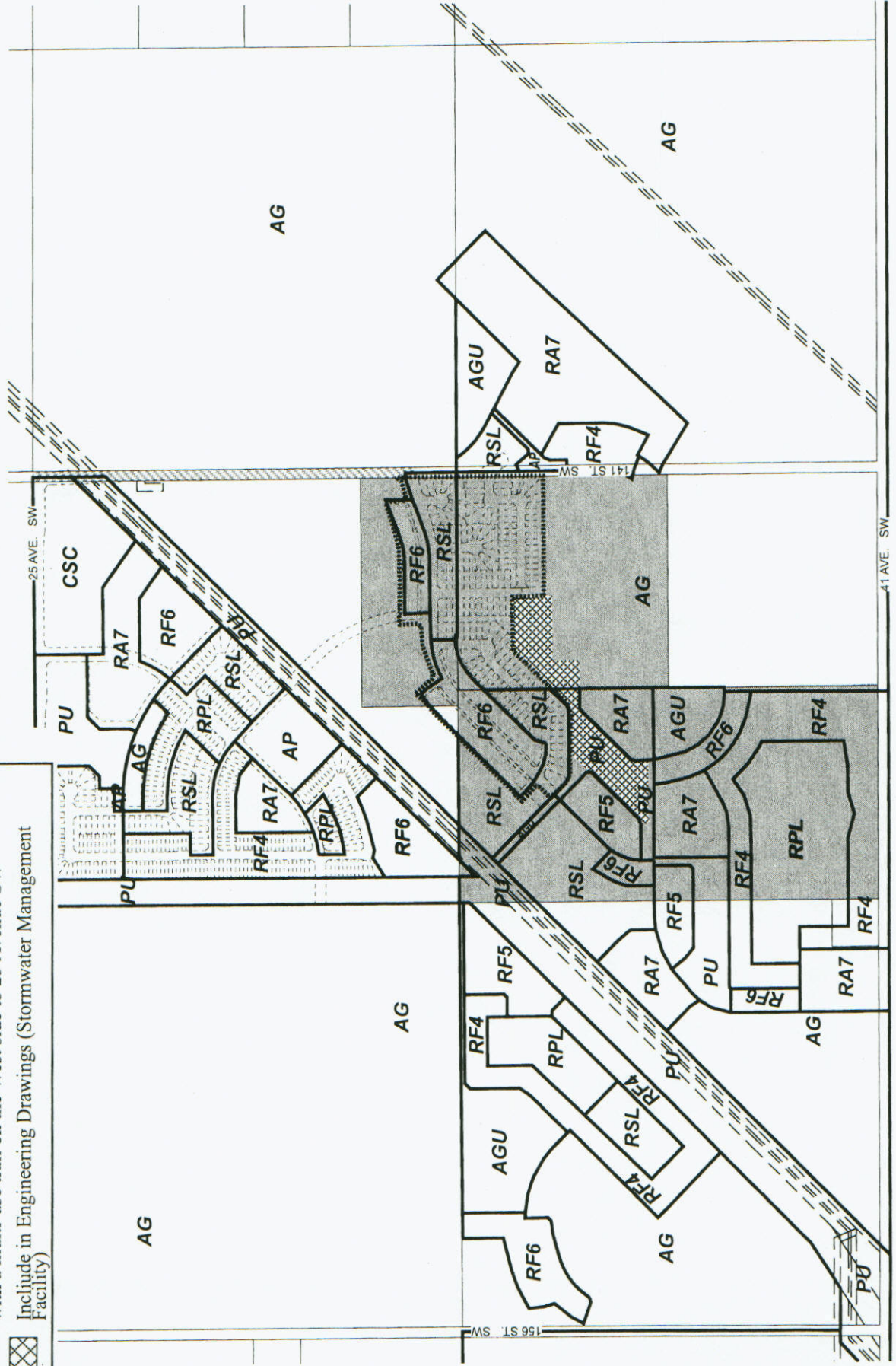

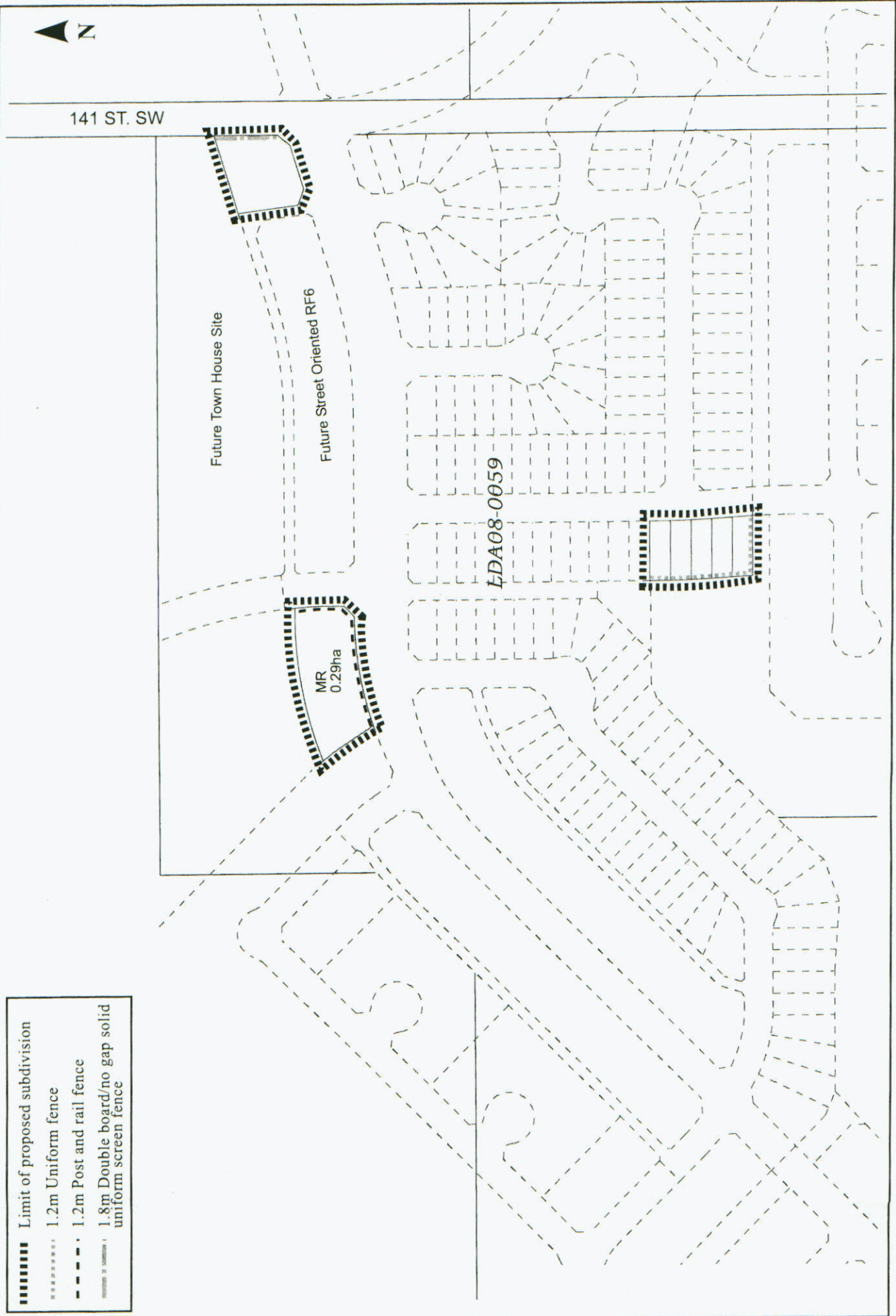

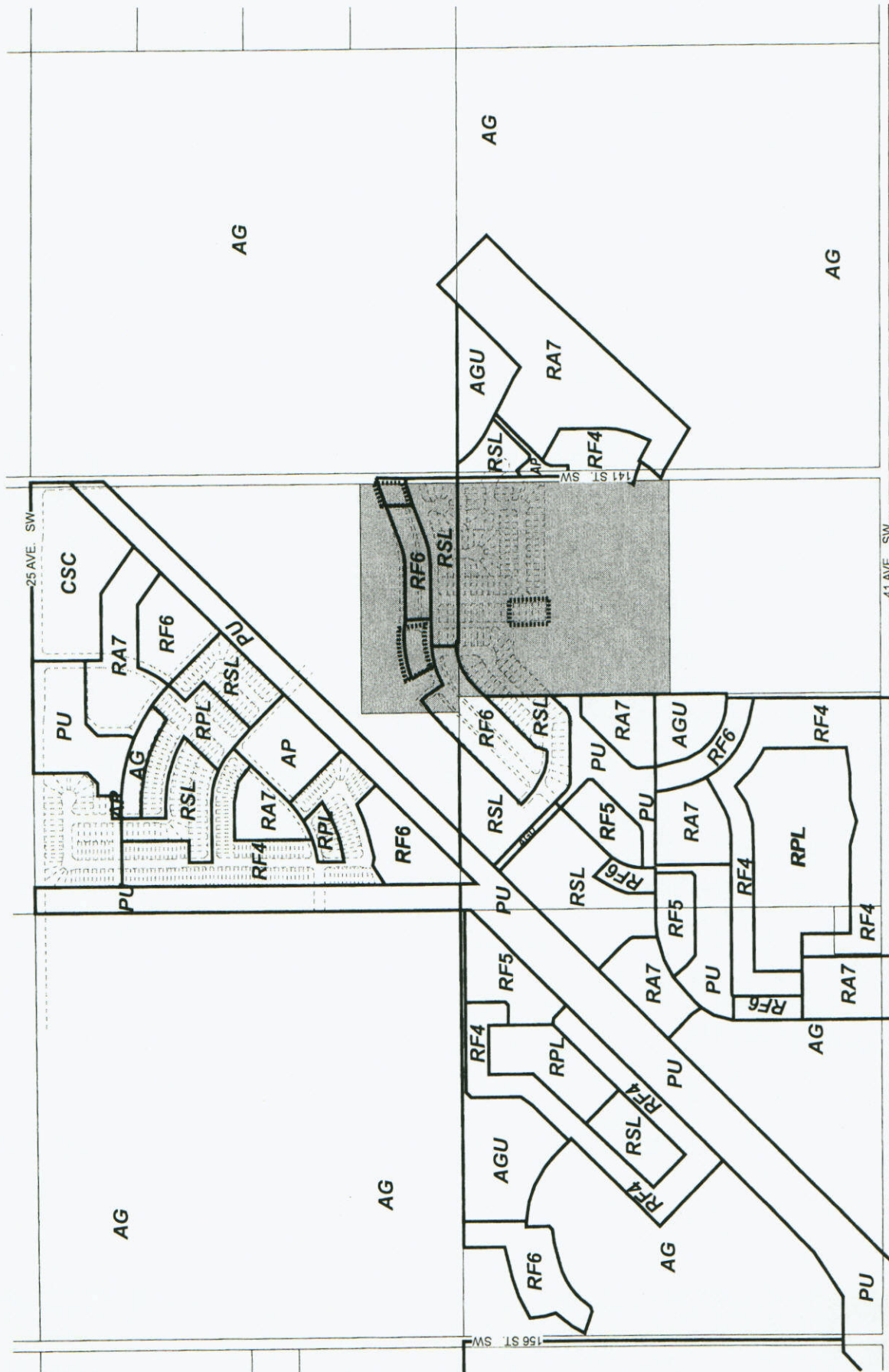
