 expectation to volunteer for work beyond the regularly scheduled meetings.

1.0 PURPOSE AND SCOPE

1.1 The role of the City of Edmonton IPM Advisory Group is to:

Provide a vehicle for the flow of strategic advice and expertise between the community and the City of Edmonton to support the ongoing implementation of the Integrated Pest Management Policy (C501A).

Facilitate public perspective on integrated pest management issues, recognizing that many of the issues are within the context of provincial and federal regulatory agencies.

2.0 MEMBERSHIP AND ORGANIZATION

- 2.1 Membership of the IPM Advisory Committee is as follows:
 - up to nine citizens-at-large;
 - potentially representation from Alberta Health Services;
 - potentially representation from Health Canada (pest-related); and
 - up to three representatives from different post-secondary institutions in Edmonton.
- 2.2 The IPM Advisory Group provides advice to the Director, City Environmental Strategies (to be confirmed).
- 2.3 Meetings of the IPM Advisory Group are typically held quarterly or more frequently as occasionally required and annually with Director, City Environmental Strategies (to be confirmed).
- 2.4 All members are expected to serve for a two-year term, with an opportunity to renew their commitment for one additional two-year term.
- 2.5 Individual IPM Advisory group representatives may volunteer for specific initiatives that could require additional work beyond that at the regular meetings of the committee-as-a-whole.

2.6 City of Edmonton Enviso staff will act as a resource and facilitator for the IPM Advisory Group.

3.0 ROLES AND FUNCTIONS

- 3.1 To review, comment on and provide perspective on short-term, intermediate and long-term Integrated Pest Management initiatives and strategies. It will also provide strategic advice on emerging issues and opportunities for public and stakeholder engagement.
- 3.2 To provide perspective on pest management activities that accounts for human health and safety, long term ecosystem sustainability and efficacy against the target pest.
- 3.3 To raise new, relevant, unexplored IPM issues germane to Edmonton and the region.
- 3.4 To advise on appropriate consultation between the City, the identified stakeholder groups and the community-at-large concerning integrated pest management matters.
- 3.5 In carrying out its responsibilities, the Committee will give due consideration to social and economic aspects within an environmental context.
- 3.6 Members are expected to review the agenda package in advance of meetings,
- 3.7 Regular attendance at meetings is expected of IPM Advisory Group members.
