- Provide solutions which incorporate accepted best practice in universal design with respect to, but not limited to:
  - Curb ramp locations and orientation; in particular, at the corner of 101 Street and 103 Avenue; and
  - Sufficient differentiation of tactile surfaces

- Address potential tripping hazards caused by the bench design which incorporates a gradual slope to grade and may not be perceptible by persons with visual impairments
- Additional design refinement to ensure winter interest through means such as colour, lighting and material selection
- Revised sun shadow study, considering the impact of the surrounding context, with respect to shadows cast, to demonstrate adequate sunlight is available for the growth of plant material as shown.
- Confirmation whether existing trees are being relocated and / or salvaged
