1.2 Pursuant to Traffic Bylaw 5590, the following are designated as dangerous goods storage locations and prohibited dangerous goods restricted highways respectively.

### **DANGEROUS GOODS STORAGE LOCATIONS**

The following locations are permitted vehicle storage locations:

- 1) Any area that is not a highway, as defined in the Traffic Bylaw, Bylaw 5590, and:
  - a) is a minimum distance of fifty metres (50 m) from any building where the building, or any portion of the building, is used:
    - (i) by a gathering of persons for civic, political, travel, religious, social, educational, recreational, retail or like purposes, or for the consumption of food and drink;

- (ii) by persons harbored or detained to receive medical care or treatment, or by persons involuntarily detained; or
  - (iii) by persons for who sleeping accommodation is provided; and
  - b) is a minimum of fifteen metres (15 m) from any other building.
- 2) Any location approved for vehicle storage by the City Manager.
