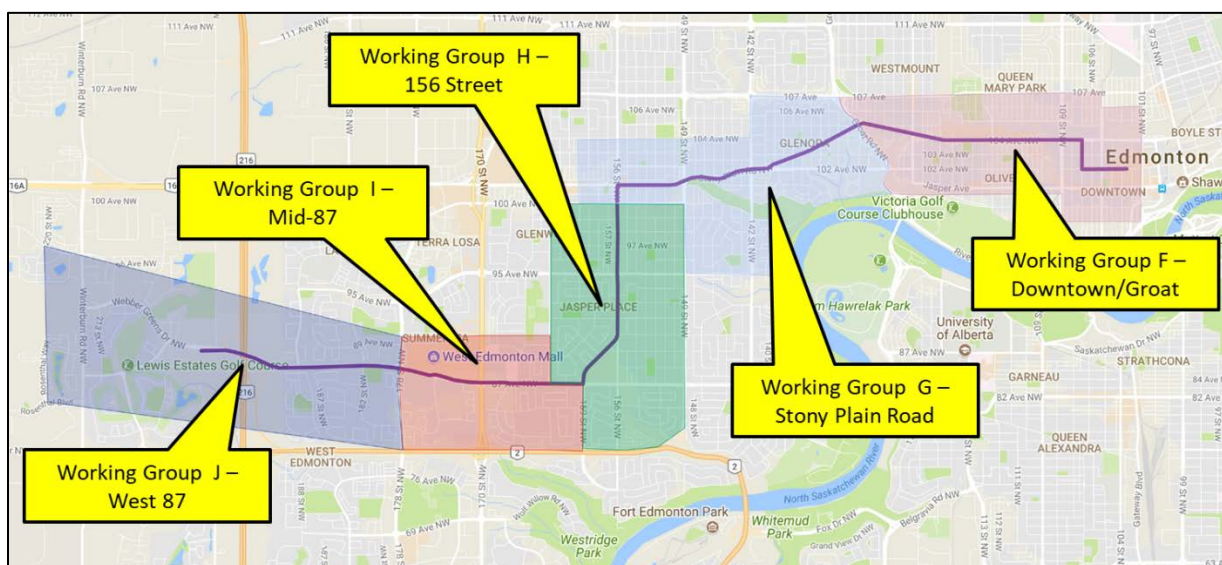
PURPOSE

- Local representation
 - 1 assigned by each community league
 - 2 from the community at large
 - Representation from local business community where applicable
 - 1 from each community group having major presence
 - 1-2 representing local schools, in consultation with school boards
 - 1-2 from seniors community, in consultation with Seniors Coordinating Council
 - 1 from the administration of a major institution if present/applicable

GUIDELINES

Membership

- Volunteers to be representative cross-section
- Group to function until Valley Line West begins service (possibly to be extended into service period)
- Membership/composition reviewed annually

Conduct of Meetings

- Facilitated by City's Community Relations Advisor / Public Engagement Lead
- Regular & timely sharing of information
- Identify issues, opportunities & concerns
- No decision-making (City's mandate cannot be delegated)
- Alignment, concept, preliminary design (except elements identified by the City as under review) & procurement method may be discussed for information purposes but not up for debate
 - City will not revisit key past decisions
- Members to understand/share local knowledge & interests
- Mutual respect & trust
- Support overall best interests of community
- Treat participation as a commitment
- Meetings open to attendance by the public as observers (guidelines established for questions / speaking opportunities)

Scheduling, Agendas, Facilities etc.

- Meeting frequency, times, duration flexible; determined by group
- Topics identified in advance
- Agendas & minutes posted on website
- City to arrange / provide facilities

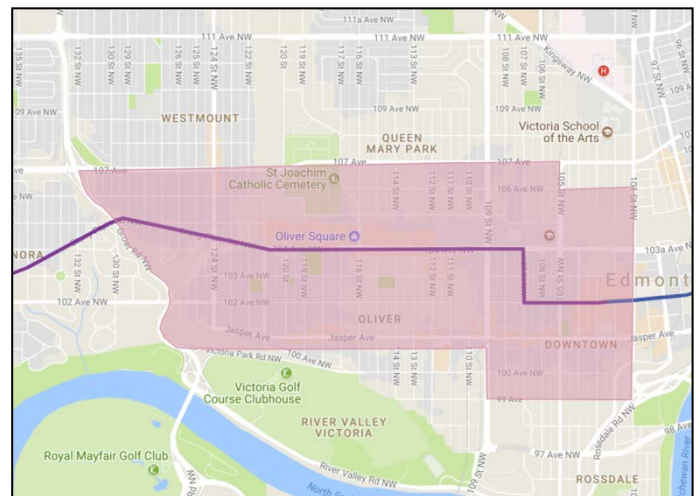
Recent & Upcoming Activities

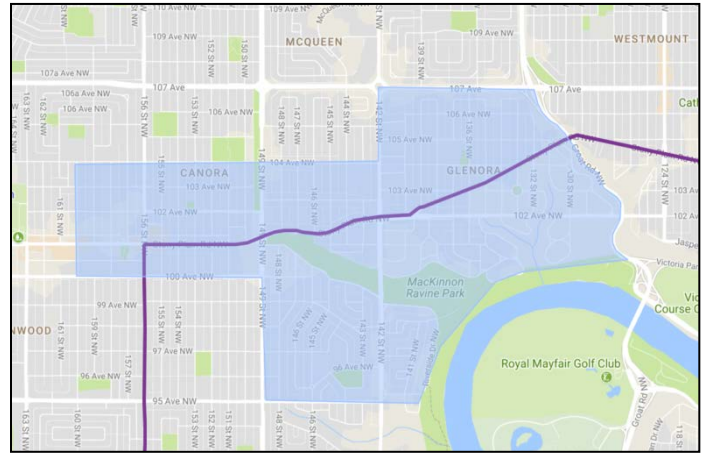

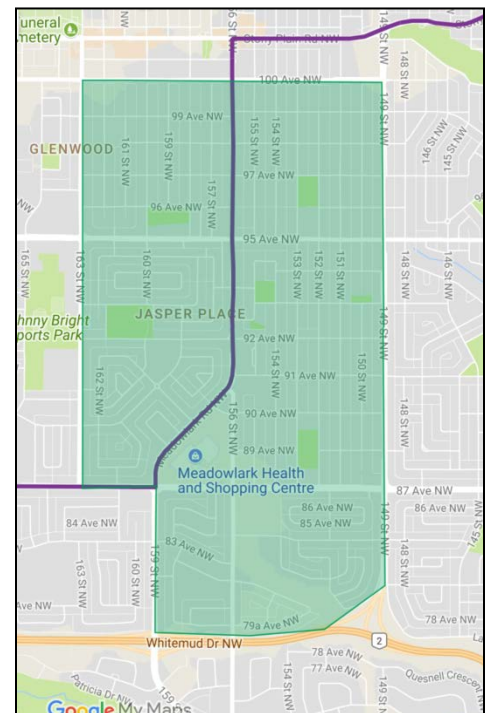

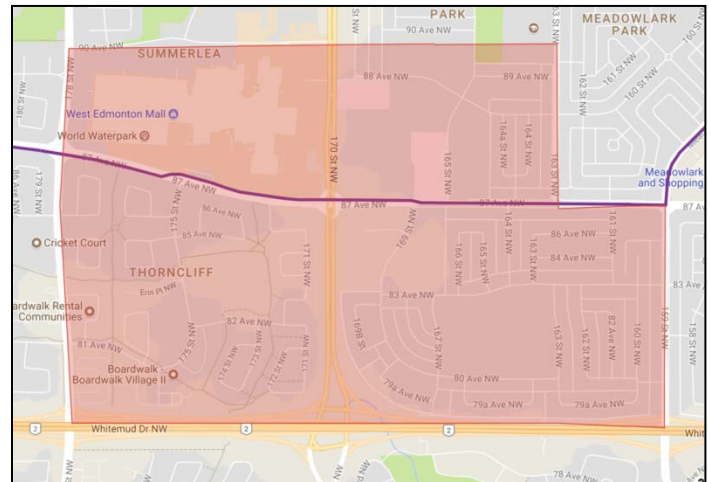
