All members of the Corporate Climate Leaders Program must meet the following three commitments within 12 months (for #1 and #2) and 18 months (for #3) of joining the program:

- (1) Establish and maintain a corporate GHG inventory that is compliant to international protocol,
- (2) Develop a GHG reduction plan and target(s) for reducing emissions, and
- (3) Share certain details of these commitments publicly. For details please see the consent form below.

- As of today, is your business or organization:
 - Currently meeting all three of these requirements or
 - Currently not meeting these requirements but will take steps in the next 12 months (as part of the program) to meet them fully?
- Please note that for verification purposes, you will be asked to provide a letter from a 3rd party confirming that your inventory and plan comply with international GHG protocol. If known, who do you expect would be providing your organization with this letter?
- Are you interested in learning more about Green Economy Canada services to help you meet the program commitments (which includes providing 3rd party verification) or improve your GHG management practices?
- Given what you know about Green Economy Canada, do you intend to register for their support services (which includes training sessions in Edmonton) to help with your GHG management practices?

SECTION IV - CONSENT

This consent form is only applicable to information related to your business or organization's corporate GHG emissions (as outlined below) provided to the City of Edmonton during the term of May 1, 2020 to May 1, 2022.

- By submitting this form, you confirm that:
 - You consent to information on your business or organization's participation in Corporate Climate Leaders Program being collected, used and stored internally by the City of Edmonton.
 - The information you share with the City of Edmonton is accurate, to the best of your knowledge.
 - You consent to sharing certain details about your GHG inventory & management plan with the City of Edmonton. This information will be posted on the City of Edmonton website and it will be used for reporting and program development purposes. Specifically, the information shared will include your total annual GHG emissions (total emissions from electricity, natural gas, transportation and waste), GHG reduction target(s), operational boundaries and baseline year. No other details will be shared without your consent.
 - You authorize the City of Edmonton to disclose publicly your business or organization's participation in the program (by name only).
 - You understand and approve the removal of consent process outlined below.
 - You understand that you will need to provide proof (via letter from a third party) within 1 year that you have met all program requirements in compliance with international GHG protocol.
- Optional Consent: Once available, do you intend to share your entire GHG inventory & reduction plan (or detailed elements of them) with the City of Edmonton for publication on the Corporate Climate Leaders Program website?
