




COVID-19 Fitness for Work Self Screening Expo Centre



Edmonton

April 5, 2020

The following document outlines the Fitness for Work Self Screening requirements for employees reporting for duty at the Expo Centre and if you suddenly become symptomatic while on site.

Employee Responsibilities

1. All City of Edmonton employees working on site at the EXPO Centre for COVID-19 are required to conduct the self screening assessment process in their home prior to attending the facility. The self screening assessment is outlined below.
 - a. Employees must answer “No” to all questions on the COVID-19 Fitness For Work Self Screening Questionnaire below each day **before reporting to work**.
 - i. If you select yes to any one or multiple questions, do not report to work. Immediately complete the [Online AHS COVID-19 Assessment \(Healthcare and Shelter Workers/Enforcement Personnel/ First Responders self assessment tool\)](#).
 - ii. Report to your supervisor on the result of the assessment and determine how to proceed.
2. At the worksite, employees must check-in and out daily at entrance 5.
3. If at any point in time during the day employees are experiencing the symptoms listed below, complete the *Healthcare and Shelter Workers/Enforcement Personnel/ First Responders* self assessment tool and follow the recommendations of the self assessment.

4. Advise your supervisor if the assessment directs you to self-isolate.
5. Follow the information as outlined on the AHS Self-Assessment Tool.

COVID-19 Self Assessment for Healthcare and Shelter Workers/Enforcement and Personnel/ First Responders

Updated April 5, 2020

A targeted approach to testing for COVID-19 is being implemented in Alberta to help prioritize groups at highest risk of local exposure and at-risk populations. This approach is consistent with testing happening across Canada. Use this online [self-assessment tool](#) to help determine whether you need to be tested and to get additional advice on COVID-19, such as the need to self-isolate.

Testing will be prioritized for symptomatic individuals in the following roles:

- Healthcare workers;
- Group home workers and shelter workers;
- First responders, including Firefighters and EMS;
- Those involved in COVID-19 enforcement, including,
 - Police, Peace Officers,
 - Bylaw Officers,
 - Environmental Health Officers,
 - and Fish and Wildlife Officers; and,
- Correctional facility staff, working in either a provincial or federal facility.
