As a business ladies league, membership is available to any woman who is employed/self-employed.
Registration and membership rules are as follows.

- Registration is limited to 175 members.
- **Registration deadline for new & returning members is March 15, 2017.**
- Returning members fill available spots first.
- *Members must establish and/or maintain an up-to-date handicap to be considered a returning member. A minimum of 6 rounds must be played at Victoria during evening league play (Monday nights or Tuesday nights following statutory holidays) and posted by Sept 30 each season. Failure to fulfill this commitment for the current golf season will result in ineligibility to register for the following golf season.*
- **NO LATE REGISTRATIONS WILL BE ACCEPTED.**
- **NO REFUNDS WILL BE PROCESSED AFTER APRIL 30, 2017.**

DRAW PROCESS:

If more than 175 registrations are received by March 15, each year, new registrants are placed in a draw.

Unsuccessful applicants will be given one additional draw ticket for each subsequent year that they enter the draw, thereby increasing their chances each year.

Two or more executive members will be present at the draw.

All registrants will be informed of their membership status shortly after the registration deadline.
