Capital Line South LRT Utility Relocation Project 111 Street Between 12 Avenue and Saddleback Road NW

PROJECT OVERVIEW

As part of the Capital Line South LRT Extension Project, EPCOR is responsible for relocating all the power, water and drainage utilities to avoid potential conflicts with the future Capital Line South LRT extension infrastructure. This is an extension of the current Capital Line, which will operate from Century Park to Ellerslie Road.

WHAT'S HAPPENING?

To meet the overall LRT project schedule, the City of Edmonton has requested that EPCOR perform the utility relocations within specific areas along the proposed route before LRT construction. EPCOR has been in the area for the past year, completing utility relocations ahead of the construction of the Capital Line South LRT. This notice provides updated timelines for the remaining work, which will continue into 2024.

HOURS OF WORK

Regular working hours are **7:00 a.m. to 7:00 p.m. Monday to Saturday**, and **Sundays from 9:00 a.m. to 5:00 p.m.**

At times, we may need to work overnight to minimize impacts to the area.

EPCOR will do everything possible to manage noise associated with the construction and will work to ensure that the construction is completed within the requirements of the City of Edmonton Noise Bylaw.

SCHEDULE

Power Work Area

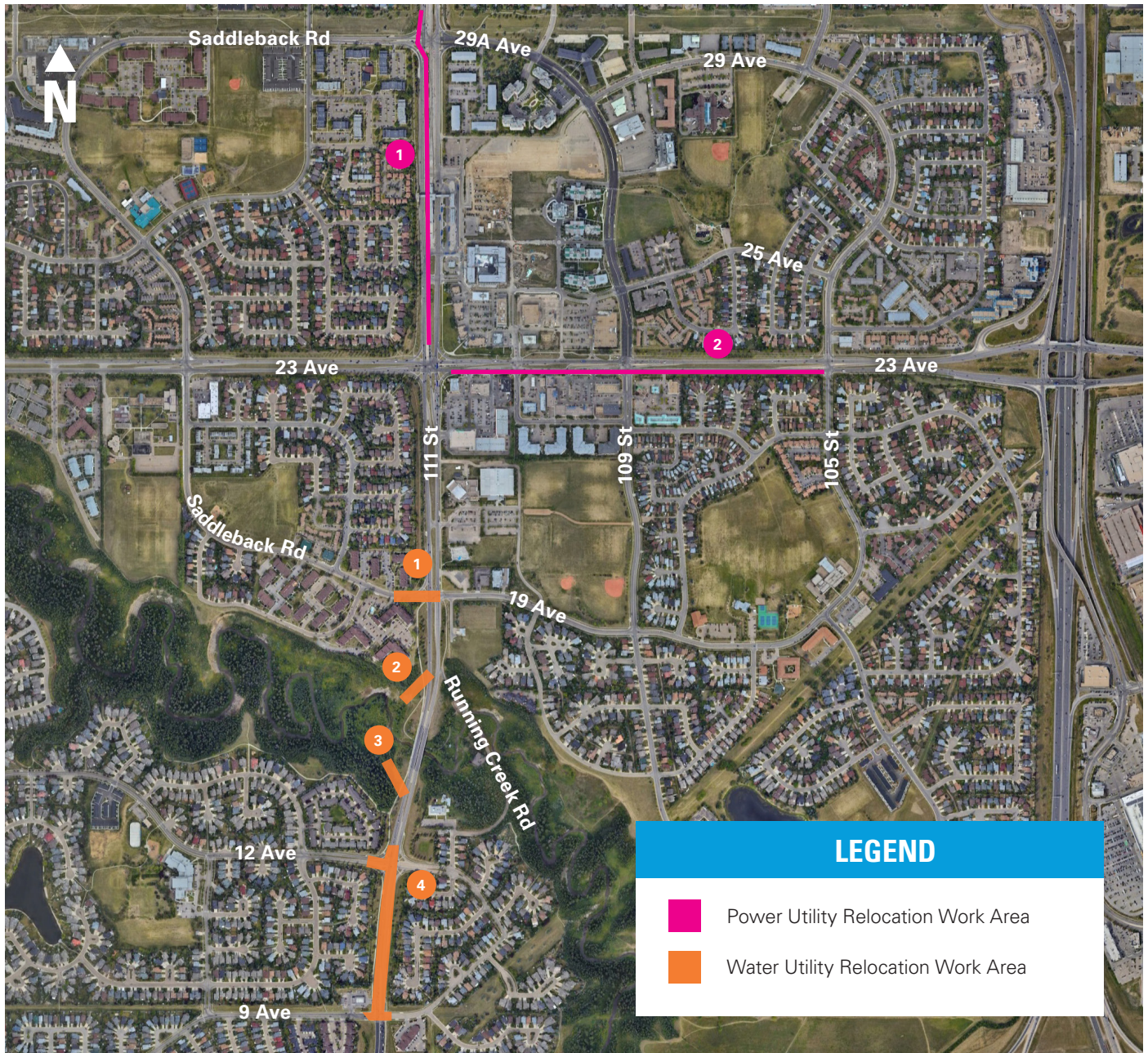
- 1 Underground power cable upgrade along 111 Street from 23 Avenue to Saddleback Road. Expected to start in **May 2024** and anticipated to be completed by **fall 2024**.
- 2 Underground power cable upgrade work along 23 Avenue from 111 Street to 105 Street. Expected to start in **summer 2024** and anticipated to be completed before **the end of 2024**.

Water Work Area

- 1 Water main relocation on Saddleback Road/19 Avenue at 111 Street. Expected to start in **summer 2024** and anticipated to take **one month** to complete.
- 2 Water main relocation on the north side of the Blackmud Creek overpass. Expected to start in **fall 2024** and anticipated to take **one month** to complete.
- 3 Service installation on the south side of the Blackmud Creek overpass. Expected to start in **summer 2024** and anticipated to take **one month** to complete.
- 4 Water main relocation on 111 Street from 9 Avenue to 12 Avenue. Expected to start in **summer 2024** and anticipated to take **three months** to complete.

Timelines are estimates and may change based on weather and construction conditions.
