

EDMONTON COMBATIVE SPORTS COMMISSION FINAL MEETING MINUTES

May 9, 2022 7:00 PM Online via Google Meet

1. Call to Order and Land Acknowledgement

The meeting was called to order by Acting Chair, Trevor Kelly, at 7:03 pm., Monday, May 9, 2022.

The Edmonton Combative Sports Commission acknowledged the traditional land on which we reside is Treaty 6 Territory. We would like to thank the diverse Indigenous peoples whose ancestors' footsteps marked this territory for centuries. We acknowledge that this is also Métis homeland and the home of one of the largest communities of Inuit south of the 60th parallel. Courtoreille will confirm that there are no issues with increasing the budget and bring forward the motion to the next meeting making sure it is not outside of the procurement process. The Commission will look at holding these sessions at Commonwealth Stadium on June 9, and 16, from 7:00 pm until 8:30 pm with 8 to 10 people per session.

T. Courtoreille is meeting with Law and the Branch Manager of Community Standards and Neighbourhoods this week regarding the status of combative sports in Edmonton. The Deputy City Manager is recommending a discussion about the need for a provincial commission.

The Executive Director will find out what he can share with the Commission regarding the pending lawsuit and report back.

The status of the \$10,000 paid back to the City is still unknown. T. Courtoreille is looking into it and hopes to have an update for the June meeting.
