The City of Edmonton is seeking proposals from innovators that will simultaneously rehabilitate Hangar 14 while working with the Alberta Aviation Museum to continue the vision of an aviation museum in a World War II-era hangar.

Hangar 14 is a 84,400 sq.ft. building sitting on a 5.89 acre portion of land. The Hangar consists of an open beam warehouse/hangar area with office areas dispersed throughout the building. There are open spans within the hangar of over 110 feet.

All proposals must include and assume the Aviation Museum Lease and their space requirements. In addition, Hangar 14 is a legally protected Provincial and Municipal Historic Resource.

Any additions or alterations must be approved by both the City of Edmonton and the Government of Alberta.

 - Provision of a deposit in the amount of 10% of the purchase price upon execution of a Sale and Development Agreement and a Performance Fee of 10% of the purchase price. All development shall comply with the development regulations contained in the Mature Neighbourhood Overlay and the City Centre ARP.
3. The property is being sold on a strictly as is, where is basis. 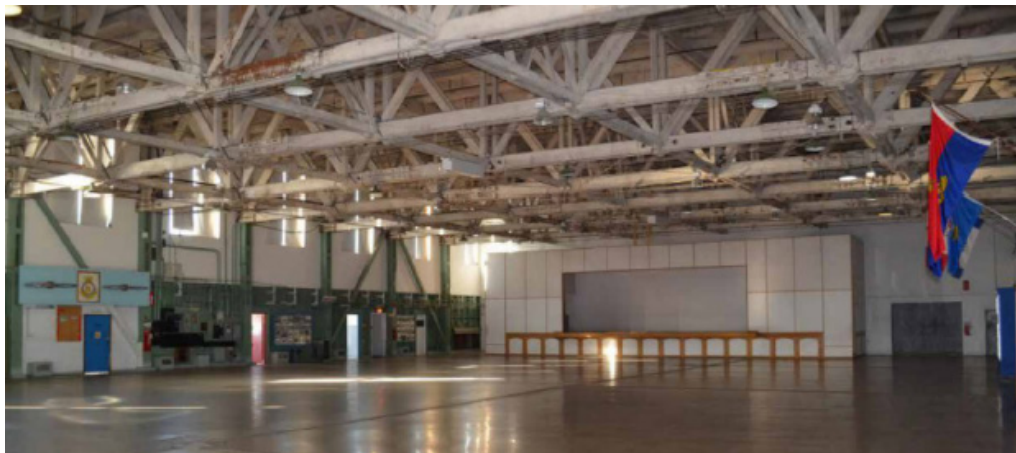
