The following is a high-level overview of the Edmonton Economic Recovery Grant - City Stream (Individual Business Grants).

#### Edmonton Economic Recovery Grant - Performance Metrics (as of April 15th, 2021)

Total number of businesses supported: 1,087 Total grant funding awarded: \$1,115,000

Grants issued to business owners who identify as part of an underrepresented group<sup>1</sup>: 830/1087 (76%)

Grants issued to businesses that identify that they serve an underrepresented group(s): 277/1087 (25%)

#### Top 5 Uses of Grant Funding:

- 1. Short Term PPE/Cleaning (56%)
- 2. Marketing/ Advertising (15%)
- 3. Updating/Establishing Online Presence (14%)
- 4. Equipment Purchase(s) (9%)
- 5. Establish E-Commerce (6%)
