Calder Renewal Newsletter Issue #5 - September 2020

Through the Building Great Neighbourhoods and Open Spaces Branch, the Neighbourhood Renewal Program rehabilitates your residential roads, replaces street lights, sidewalks, curbs and gutters, and adds missing sidewalk links in your neighbourhood where possible. Other opportunities to improve parks and public spaces are also explored. Construction is scheduled to begin in 2021.

Planning has been underway for Calder's neighbourhood renewal since January 2019. We have been busy reviewing resident feedback, understanding opportunities and constraints from a technical perspective and building on City policies and processes to develop a single draft design for the neighbourhood. We presented the draft design to the community in July 2020. In the upcoming months we will finalize the design and prepare to share it with the community in late fall.

In this newsletter we want to:

### **Reporting back on Public Engagement**

Thank you to everyone who participated in the July public engagement opportunities and contributed their knowledge and experiences to help shape the future of Calder.

We gathered feedback on topics including: parks, streets and connections, bike facility, commercial area improvements and community-led projects (i.e., placemaking and historic character). Participants were invited to a webinar to share their thoughts on the draft designs. For those unable to attend the webinars, residents could review the draft designs through the project webpage and provide input through a survey. Residents also had the opportunity to submit questions.

Overall, 15 participants joined the webinars, 41 surveys were completed, over 100 residents viewed the draft designs online and there were close to 200 views of the design videos.

We are creating a report to share the feedback we've heard from the two most recent engagement opportunities: Exploring Options and Trade–Offs, and Community Feedback On Draft Design. Below is a summary of the most common themes:

### **Accessibility and Connections**

The sidewalk repair and renewal and enhanced bike route connections throughout Calder excite residents as both will provide better and easier access for all ages and abilities.

### Safety

Calder residents indicated the school traffic flow improvements would increase the feeling of safety for people who walk, bike and drive in this part of the neighbourhood. They also noted that they feel additional lighting will improve visibility, particularly in the parks. Residents reiterated the importance of safety and hoped that these changes would contribute to creating a safer Calder. Residents reaffirmed that safety is the responsibility of all community members and the importance of keeping their properties clean and tidy to promote community pride.

### Parking

Parking remains a priority for those who drive and residents were happy to see that most on-street parking would remain. There are some who are disappointed that parking will be restricted or removed close to their properties.

### **Amenities and Recreation**

Amenities such as BBQ pits, benches and picnic tables are a welcome addition to Calder and residents believe that they will encourage residents to be more active in the neighbourhood. Residents would like more amenities to be implemented such as exercise parks and a community garden. Community volunteers have come forward to help with community-led projects.

### **Commercial area improvements**

Residents of Calder take pride in the unique business area on 129 Avenue and appreciate upgrades. They suggested that improving the aesthetics of the area may attract more and different businesses that would also encourage community members to visit the commercial area more regularly.



### **Decorative Street** light update

Community volunteers have carried out conversations with friends and neighbours in Calder to identify a decorative street light option. They are recommending a black, octagonal pole with a heritage arm and renaissance bulb.

## What happens next?

In September, the City will mail each registered property owner an "Expression of Interest" package. This package will contain both information about the estimated local improvement cost and a notice for the property owner to return to the City. The single page notice will ask property owners to select whether they support or do not support decorative street lights.

The City will need to receive a representative sample of 265 responses from property owners in Calder. If 50% plus 1 support the decorative street lights, the local improvement process will begin. If less than 20% of property owners submit an EOI form by the deadline, it will be at the discretion of the City to initiate the process or not, based on previous public engagement feedback.

HISTORY MOMENT: Did you know Calder used to be two small towns adjacent to each other? The Calder community, consisting originally of the Village of West Edmonton and the Elm Park subdivision, developed a self-sustained working class community reflected in the modest workers' cottages, commercial and community buildings, and diverse collection of churches representing the multitude of ethnic groups settled in the community through time over its occupation since the 1890s. The Village of West Edmonton was annexed by the City of Edmonton in 1917 and later became the community of Calder in the early 1900s. Elm Park remained on tax assessment bills until the 1990s.



### **Decorative Street Blade Update**

Neighbourhood Renewal includes the replacement of the street blades in your neighbourhood. Your community is recommending to install decorative blades. There is no additional cost to property owners to install decorative blades.

The Calder Community League is continuing to accept your feedback on the design for the decorative street blade design. Phase 1 was to garner feedback on the style and color. Of the choices presented in the latest newsletter and social media blitz, we heard mostly that BLACK is the preferred color for the blades.

For Phase 2, we now need to hear from you about the details of the design. Two images have been created as options. An old steam train or the date of Calder being established. Which do you prefer?



### **One Way Traffic Flow** in front of Calder schools



The Calder Renewal Project Team has decided to implement the one-way traffic flow change in front of Calder School and St. Edmund School this fall when school starts up. This test run will involve changing signage in front of and adjacent to the two schools, to provide new traffic direction to people who drive.

#### Starting on August 24, 2020, traffic flow along 130 Avenue and 118 Street will be changed from two-way travel to one-way travel.

Traffic flow will be changed to westbound only on 130 Avenue starting at 117 Street and southbound only on 118 Street through to 129 Avenue. Parking on 118 Street from 131 Avenue to 132 Avenue will be removed on the east side.

Implementing the one way travel allows us to observe the impacts to traffic flow, student drop off and pick up, pedestrian crossings and visibility for people who are driving or walking.

We intend to keep the traffic measures in place until Neighbourhood Renewal construction occurs in front of the schools. If we find we need to make adjustments to the one-way traffic flow and parking restrictions, we may make changes to fine tune the design.
