## ADDITIONAL REQUIREMENTS

- You **must** complete the Business Licence Information Course before applying for your licence.
- You must be 18 years or older to be eligible for a licence.
- Include a police information check (PIC) with your application
  - **Your PIC must be from the Edmonton Police Service (EPS).** PICs from the RCMP, private companies, or any other police service cannot be accepted.
  - Your PIC must be no more than 90 days old.
  - A complete and legible copy is acceptable.
  - If you have already supplied a PIC for another business licence within the previous 12 months, you may not need to provide another one at this time.
  - If your PIC has charges, convictions, or any other information to disclose, consultation with EPS may be required. This process typically takes up to 15 business days.
- When we process your application, a staff member will contact you for the following:
  - A photograph
  - A government issued photo ID

Collection is authorized under section 33(c) of the Freedom of Information and Protection of Privacy (FOIP) Act and is managed and protected in accordance with the Act. The information in your application may be shared with other applicable government bodies or enforcement agencies for the purposes of notifying the affected entities of your application for a business licence, or for requesting input from the affected entities to assess your application for, or determine appropriate conditions, if any, for a business licence.
