

Where We Are Now: 2012-2013 Concept Planning Study

- The previous phase identified the route the LRT should follow
- This Concept Planning Study is to develop a concept plan that:
 - Defines specific location of tracks & stations within the approved route
 - Defines the layout of stations

Strategy

- Defines property requirements (if any)
- Defines auto access requirements for adjacent properties
- Considers ease of access & interchange for cyclists, pedestrians & bus users
- Provides necessary information to begin preliminary engineering

What has changed?

- A revised concept plan for the 153 Avenue corridor that creates greater flexibility for the City to develop and deliver the system design and operation.
- The benefits of this new design is that LRT could operate at a higher speed on this portion of the corridor; should it operate at higher speed it would require gates and bells.
