Mandate

Through partnerships, celebrations, and engagement with multicultural, further established immigrant, and newcomer communities this initiative aspires to ensure that they are provided opportunities so they can thrive within their communities while actively participating and contributing to the civic life of Edmonton. The approach of this initiative will be one of cross-cultural education and relationship building which will encourage new experiences and conversations.

Desired Outcomes

- Outcome #1: Support for gatherings and events within the multicultural, immigrant, established and newcomer communities making Edmonton a more dynamic and inclusive city.
 - Participation in community events was ad-hoc in the past. Moving forward the initiative seeks to partner with a minimum of four events annually, outside of established events within multicultural communities to provide opportunities for emerging groups to make space within the city.
- Outcome #2: Support and facilitate multi-sector efforts towards inclusion and cohesion through the Edmonton Local Immigration Partnership (ELIP).
 - Build and nurture relationships and partnerships with neighbouring municipalities around information sharing, advocacy, and action to better serve the newcomer populations that work, live and play in Edmonton
 - Support for the exploration of services provided to newcomers, and advocacy for improvements to inclusion.
 - Participate in ELIP gatherings and celebrations alongside the province and Immigration, Refugee and Citizenship Canada.

 - Partnership and coordination with other departments on intentional outreach into communities to ensure their inclusion in civic engagement processes.
