10. I understand that even if this application for transfer is approved , I will still need to satisfy all of the requirements of the City of Edmonton Vehicle For Hire Bylaw No. 14700 within sixty (60) days of the date endorsed hereon approving the transfer.
11. I understand that if I fail to satisfy all of the requirements of the City of Edmonton Vehicle For Hire Bylaw No. 14700 within the sixty (60) days provided, Taxi Vehicle Licence Number \_\_\_\_\_ will not be issued to me, and I will not have any right or claim to that Taxi Vehicle Licence.
