- Linda Cochrane opened the meeting with welcome and introductions, a summary of the community benefits meetings held to date, and City Council milestone decisions. She indicated that though there remains a funding shortfall for the arena project, the purpose of this meeting was to keep the community benefits discussion going by starting a conversation with the local community, the Oilers and the City of Edmonton. As such, the primary reason for the meeting is to discuss a draft Terms of Reference for the proposed Arena District Local Advisory Committee its purpose, mandate, committee composition and meeting schedule.
- Rick Daviss provided an update on the arena project as a whole project history, arena design, community rink, master agreement, budget and next steps.
- Rob Smyth reviewed the Community Benefits Schedule D, a component of the Master Agreement as approved in principle by City Council on April 10, 2013 and reviewed the draft Terms of Reference for an Arena District Local Advisory Committee.
- Patrick Laforge welcomed the opportunity to work with the local communities and organizations. He acknowledged that open dialogue is needed and is looking forward to developing long term relationships with community groups.
- All participants took part in discussion around the composition of the proposed Arena District Local Advisory Committee. Linda recommended that Stakeholders share the draft Terms of Reference with their organizations and begin to think about who their representative might be. In the meantime, the City will consider all feedback received around Committee composition.
- A number of items were identified as potential topics for discussion at upcoming meetings including:
  - 1. Possibility of having an open house once a year for the broader community.
  - 2. Employment options during construction and for operations once arena opened.
  - 3. Parking around the Arena during events
  - 4. Meeting specifics: Date, Time, Location
- It was agreed that should City Council approve the Arena project, the next meeting
  of this group would be held in the fall of 2013.
- Linda concluded the meeting by thanking all for their attendance and participation.
