



Commonwealth Stadium and Clarke Park Area Residents

Vehicles must display a valid permit to park on the street in nearby neighbourhoods during major events at Commonwealth Stadium and Clarke Park.

Parking restrictions go into effect two hours before an event begins and end one hour prior to the scheduled end of the event. Vehicles violating these restrictions will be tagged and towed.

Permits are available to residents of single family homes and multi-family buildings three (3) stories or less in height within the program area. To obtain an annual residential parking permit you must reside within the program area and provide proof that your vehicle is registered to the address in the program area.

Each year, in the spring, the City will make available a bulletin including the list of Major Stadium Events.

Edmonton's Residential Parking Programs



Edmonton

Residential Parking Program areas were established to ensure parking would be available for residents in areas with a high on-street parking demand (e.g. near large sport facilities, educational institutions).

Permits

Permits are available to residents of single family homes and multi-family buildings three (3) stories or less in height within the program area. There are three types of Residential Parking Permits: Annual, Visitor, and Temporary.

Fees

There is no charge for residential parking permits at this time.

Annual Permits

This permit allows residents within a Residential Parking Program area (i.e. a neighbourhood with signs along the streets stating "Except Residents With Valid Permit") to park their vehicles on the street.

Maximum 2 permits per household.

Valid vehicle registration is required along with proof of residency. Items used as proof of residency can be a driver's licence, utility bill, lease agreement or purchase agreement, or a letter from the landlord. If the vehicle is registered in someone else's name, then a letter authorizing vehicle usage is required from the registered owner (e.g. if an offspring is using the parent's car, a letter from the parent authorizing such use is required.) **Company vehicles that are not registered to the residence are not eligible for a permit.**

The permit must be displayed on the drivers side front windshield and must be completely visible from the outside of the vehicle.

Once a resident has applied for and obtained a permit the first time, a renewal letter is sent out each year and the annual permit is sent in the mail.

Visitor Permits

Only residents in certain Residential Parking Program areas (Rossdale, Royal Gardens, UA-4 and Mini Programs) are eligible for visitor permits. These permits allow visitors to park adjacent to or in close proximity of the address as stated on the permit. Visitors must obtain a visitor permit from the resident and display it on the dash so it is visible from outside the vehicle.

Each time a visitor permit is requested by a resident, the "Visitor Parking Permit Condition Form" must be completed and signed. Only two visitor permits are allowed each year for each household.

Temporary Permits

All Residential Parking Program area residents are eligible, under certain guidelines, for temporary permits. Allowances are made for renovations, out of town guests, seniors, disabled persons and one-time social events like weddings or barbecues.
