## Proof of Income:

***A copy of any ONE of the following must be included to be eligible for Tier 1 or Tier 2:***

- ❖ 2019 or 2020 T4A (OAS) (if box 21, net supplement paid, shows any amount above zero)
- ❖ Guaranteed Income Supplement (GIS) letter of eligibility from the Government of Canada
- ❖ 2019 or 2020 Notice of Assessment (line 15000, taxable individual income must be below \$33,033)
- ❖ Permanent Resident or a refugee document (to qualify, you must have been in Canada less than 1 year and have not filed a tax return)
- ❖ Proof of government Employment Insurance (EI) being received in the past 3 months
- ❖ A copy of your Health Benefits Card within the last 3 months showing receipt of Income Support benefits
- ❖ A copy of your Canada Pension Plan T4A(P) Form for the 2019 or 2020 tax year showing credits for Disability Benefit

Once your submission has been reviewed and payment has been received (if applicable), your annual pass will be mailed to you via Canada Post (to the address you submitted on this application).

Please note that lost or stolen passes will not be replaced free of charge. Passes are non-transferable and **can only be used by the person they were purchased for.**
