

## About this Report

### FOIP Statistics - April 1, 2023 to March 31, 2024

The City of Edmonton provides statistics to the Government of Alberta for every fiscal year. The provincial government uses those statistics to prepare their annual report.

The access requests summarized in this report were processed under the *Freedom of Information and Protection of Privacy* (FOIP) Act.

#### Terms used in this report

*Completion time:* The total duration required to fully process an access request from start to finish. Annual reports track these durations by documenting the number of files closed within four specific brackets:

- 30 calendar days or less
- 31 to 60 calendar days
- 61 to 90 calendar days
- Over 90 calendar days

Note: The FOIP Act permits statutory timelines to be extended for reasons such as a high volume of records or required public body consultations.

*Continuing request:* A specialized type of access request that remains active for a designated period (up to two years) to continuously capture new records generated on a specific subject matter.

*Disposition:* The decision on whether access to the record or part of it is granted or refused, including whether the request was transferred to another public body, if the applicant withdrew or abandoned their request.

*Request abandoned:* A status applied when an applicant is notified of the next steps required to process their access request—such as paying an initial fee or clarifying request details—but fails to respond to the public body. In these cases of inactivity, the Act provides specific legal criteria to officially declare the request abandoned and close the file.

*Request withdrawn:* A status applied when an applicant explicitly chooses not to pursue their request, resulting in the file being closed.
