<a href="#">1.0 City of Edmonton's Zoning Bylaw</a>	<ul style="list-style-type: none"><li>- At the June 30, 2025 City Council meeting requested that Administration prepare an analysis of how Lodging Houses are defined, regulated, and permitted and provide options to further regulate their size and location to ensure that impacts and their operations are regulated appropriately through Zoning Bylaw 20001 or Business License Bylaw 20002.</li><li>- Concerns that lodging houses are unpermitted, new infill houses are being built as lodging houses and enforcement concerns for nuisance properties.</li><li>- Report going to the Urban Planning Committee on June 29, 2026.</li><li>- Working closely with business licensing and land compliance.</li></ul>
