The Leisure Access and Ride Transit Programs Application Guide is designed to assist you in completing the Leisure Access and Ride Transit application form. More information can be found at https://www.edmonton.ca/programs_services/leisure-access-program

General information on the Programs and Application

Who might qualify: Individuals might be eligible for one (or both) programs if:

- You are a Low income household living in Edmonton
- You make less than 125% of the low income threshold amounts for your household size
- You are low income but not able to file taxes in Canada yet (within one year of arriving) with Refugee or Permanent Resident documents

Who might not qualify: Individuals might not be eligible for one (or both) programs if they are:

- **Transit program only** - Aged 65 and over (See: [Seniors Fares - Edmonton Transit Service](#)) or Aged 5 and under.
- **Transit and/or recreation programs**- Students currently taking full-time classes at NAIT, MacEwan University, NorQuest College or University of Alberta and who have the option to join for a fee, reduced transit fares such as the U-Pass and/or pay fees/tuition toward their school's recreation facilities.
 - Student's spouse/common-law partner and their dependants aged 17 or younger may still be eligible if they meet the required Eligibility Qualifications.
- **Transit program only** - Canadian National Institute for the Blind (CNIB) card holders.
- **Transit program only** - Applicants that receive discount Transit through another organization
- **Transit and/or recreation programs** - Applicants who exceed the Income Threshold in the *Income Qualifications* section (Statistic Canada's Federal Low Income Cut-Offs for municipalities of more than 500,000 inhabitants).
- **Transit and/or recreation programs** - Individuals new to Canada applying with a Work Permit, Student Permit, or Visitor Visas who can not submit one of the listed qualifying documents such as Income support.
- **Transit and/or recreation programs** - Applicants that live outside of City of Edmonton boundaries, or move outside of Edmonton while on the program
- **Transit and/or recreation programs** Cannot provide qualifying documents from the mandatory list.

Applicants will be considered for for both programs when applying

What are the benefits if accepted on the program:

- **The Leisure Access Program (LAP)** allows eligible low income Edmontonians access to the City of Edmonton recreation facilities and attractions for free or at a reduced cost. Restrictions apply. Visit Edmonton.ca/lap for more information.
- **The Ride Transit Program** allows eligible low income Edmontonians to purchase an Adult or Youth monthly transit pass at a reduced rate. Passes are accepted by Edmonton Transit Service (ETS) and Dedicated Accessible Transit Service (DATS) for registered DATS clients. Visit Edmonton.ca/ridetransit for more information

What you need to apply for the Programs: all documents must be submitted together.

- A completed application
- One supporting low income document, from our list, for the main applicant
- One supporting low income document, from our list, for the spouse (If applicable)
- Dependant supporting document for children 17 years or younger (If applicable)

In this application a **Household** includes, an individual, their spouse and any dependants age 17 or younger, to align the Low Income Cut Off yearly gross income from StatCan. Definition of a Household in this case, does not include any children over the age of 18. Any individuals 18 years or older must apply with their own application and qualifying documents

Section 1 - Main Application Information - MANDATORY

Please type or print clearly in dark ink on your application.

In section 1 please print your information, Including First and Last name, birthdate, FULL mailing address including Apartment number and postal code.

Membership barcode numbers are only if you are renewing your Leisure Access membership and you have a scan card. This is NOT your ARC card number;. It is an optional question.

Check one box to represent your status on the program, are you currently on the programs and renewing, brand new to the program, or adding a new family member, making a change to your current membership?

Section 2 - Main Application Mandatory Questions

QUESTION 1. - Some universities and Colleges offer a discounted ETS bus pass or recreation included with the registration fees for full time students. We need to know if you are enrolled in the CURRENT semester at one of the colleges or universities listed.

- Check NO, if you are not currently enrolled full time at one of the listed schools
- Check the box next to your school, If you are currently enrolled FULL time in a semester or program at one of the listed schools . You would also need to include a fee schedule from your school with your application.

QUESTION 2. The Canadian National Institute for the Blind (CNIB) offers registration cards to its members that allow them to ride ETS for free. These CNIB members would not be registered for the Ride Transit program but would be considered for the Leisure Access program.

- Check NO, if you do not have a CNIB card
- Check YES if you are legally blind and have a CNIB card

QUESTION 3 - Your Family members make up your household and your low income eligibility is calculated on gross household income vs members in your household.

- If you **check A** this means you are SINGLE; have never been married, or currently legally separated/Divorced and you are not sharing finances or a household with another adult and have no dependants (complete sections 5 and 6)
- If you **check B** this means you are SINGLE; have never been married, or currently legally separated/Divorced and you are not sharing finances or a household with another adult and have dependant children age 17 or under (complete sections 4, 5 and 6)
- If you **check C** this means you are MARRIED, or have a common law partner and share a household and finances with another adult and have no dependants (complete sections 3, 5 and 6)
- If you **check D** this means you are MARRIED, or have a common law partner and share a household and finances with another adult and have dependants (complete sections 3, 4, 5 and 6)
- If you **check E** this means you are MARRIED, But your spouse does not live with you. Include supporting documents.

SUPPORTING DOCUMENTS if to include for your spouse not in Canada or can not file taxes in Canada

- ★ Your spouse has a Work, or Student visa and has been in Canada less than one year, - **Supporting documents to include** - your spouse's work or student visa with your application showing entry dates and **add them to section 3**. They will not be eligible for the Ride Transit/Leisure access program but will be included in your household numbers.
- ★ Your spouse has a Visitor visa to Canada and has never had a social insurance number to file taxes. **Supporting documents to include** - your spouse's visitor visa and if your qualifier is Notice of assessment you would need to include your Child Benefit or GST notice from the CRA showing world income. **Do not add your spouse to section 3** as they will not be counted in your household numbers
- ★ Your spouse has never been to Canada **Supporting documents to include** - your Child Benefit or GST notice from the CRA showing world income. **Do not add your spouse to section 3** as they will not be counted in your household numbers
- ★ Your spouse is in long term custody or medical care, **supporting documents to include** - your Child Benefit or GST notice from the CRA showing world income. **Do not add your spouse to section 3** as they will not be counted in your household numbers.

Section 3 - Spouse Information - Complete if in Main applicant question 3 you answered C or answered D, or E asked to include information on spouse with support documents

In section 3 please print your spouses information, Including First and Last name, and birthdate.

Membership barcode numbers are only if you are renewing your spouse's Leisure Access membership and not for your ARC card number; this is an optional question.

Section 4 - Dependant information - Complete if you answered F in question 3

In section 4 please print your Dependants information, including First and Last name, relation to main applicant and birthdate.

Membership barcode numbers are only if you are renewing your dependent's Leisure Access membership and not for your ARC card number; this is an optional question.

Section 5 - Consent

The main applicant must agree to the conditions for all members of their household, sign and date the application to be considered for the program.

Section 6 - Qualifying documents to be included with application

There are 8 options to show eligibility when applying for the programs.

<p>Document Required: Confirmation of Permanent Residence (PR) document (including signature and/or remarks), with arrival dates within one (1) year - for each person applying. <i>-or-</i> Refugee Protection Claimant document, with Issue dates within one (1) year - for each person applying.</p>	<ul style="list-style-type: none"> • Any household family members that do not have these documents will need to provide another qualifier. • Must provide eligible dependant verification for dependants aged 17 years of age or younger who do not have PR docs. Please see <i>Eligible Dependants Verification</i> for acceptable documentation. • You must be ineligible to file taxes in Canada, have not previously filed taxes in Canada, or previously applied using this qualifier. • If applying with a spouse that has a notice of Assessment for the current year in Canada. The permanent Residence status will be considered 0.00 gross income and added to the Notice of Assessment amount to get family income. • Work, Visitor, & Student Visas do not qualify for the program until they can submit the Notice of Assessment option.

<p>Documents Required:</p> <p>-LAP: Release of Information and Responsibility Form</p> <p>- A current copy of the Delegation of Powers that lists the child and displays one of the following: foster parent, kinship care provider, director of a foster care, or director of child and youth facility.</p>	<ul style="list-style-type: none"> ● Individuals under government care should also submit the LAP - Release of Information and Responsibility form - the individual who completes this form will be considered the emergency contact. ● The listed delegate should complete the application and all other required forms when possible. ● Each child under government care will require a separate application (as the main applicant) can not be included in a household application.

The Leisure Access Program is not offered with this qualifier.
<p>Households applying with a Registered Social Worker Letter can receive Ride Transit benefits for 1 year.</p>

<p>Documents Required: 2025 Canada Child Tax Benefit Notice (CCB) or other related tax credit document listing ALL applicable dependants aged 17 or younger and the name of the parent issued within 1 year of application date (2024 CCBs are accepted until September 30, 2026); -or- Income Support or AISH Health Benefits Statement (found on the monthly Direct Deposit statement) from within the last 3 months listing ALL applicable dependants aged 17 or younger. -or- Childcare Subsidy Letter -Must be dated within one year and have parent and child(rens) names listed.</p>	<ul style="list-style-type: none"> • If any children are listed on the application form, eligible dependant verification MUST be submitted. • Documentation must list parent/guardian and be dated within one (1) year. • If you are a legal guardian of a child under government care (aged 17 or younger), a Delegation of Powers listing Kinship care or Foster care must be provided. Each child under government care would require their own application and supporting documents. They can not be included in household numbers. • Birth certificates are only accepted when both parents are on the application and the birth certificate. • Custodial court documents must list parental rights at 50% or above
<p>Expiry dates for dependants vary depending on parent(s) expiry date, and the age of the dependant when the household applies. Dependants that turn 18 during a parent(s) membership term will expire on the anniversary of the registration date when age 18.</p>	

SUBMITTING THE APPLICATION

Applications that are completed and signed with supporting documents can be dropped off at the following locations:

Conditional approval of the Ride Transit Program is offered at the Edmonton Service Centre only. Conditional approvals are offered **only** at the time of completed application submission and only at the Edmonton Service Centre. The completed application must be filled out, signed, with all qualifying and supporting documentation.

Photo ID is required. Some conditions will apply.
