Upon obtaining a new foster pet, I agree to apply for a new Temporary Excess Animal Permit prior to the animal being brought into the home.
- All applications are subject to review/revocation at any time, by the City Manager or their designate
- I acknowledge that the City is subject to privacy legislation, including the Access to Information Act, SA 2024, c A-1.4 and the Protection of Privacy Act, SA 2024, c. P-28.5 and the information contained herein may be released only as required and in accordance with applicable privacy legislation in force in Alberta, as may be amended from time to time.
